Category	Unit	Product Description
1.	PCS	Shirts, T-shirts, Lightweight fine knit roll, polo or turtle necked jumpers and pullovers (other than of wool or fine animal hair), under vests and the like, knitted or crocheted.
2.	PCS	Jerseys, pullovers, slipovers, waistcoats twin sets, cardigans, bed jackets and jumpers (other than jackets and blazers), anoraks, windcheaters, waister jackets and the like, knitted or crocheted.
3.	PCS	Men's or boys' woven breeches, shorts (other than swimwear) and trousers (including slacks), women's or girls' woven trousers and slacks of wool or cotton or of man-made fibres.
4.	PCS	Women's or girls' blouses, shirts and shirt-blouses, whether or not knitted or crocheted of wool, cotton or man-made fibre.
5.	PCS	Men's or boys' shirts other than knitted or crocheted of wool cotton or man-made fibres.
6.	PCS	Glove, mittens and mitts, knitted or crocheted.
7.	PCS	Panty-hose (tights) stockings, under stockings, socks, ankle-socks, sockettes and the like, knitted or crocheted, other than for babies, including stocking for varicose veins, other than products of category 24.
8.	PCS	Men's or boys' underpants and briefs, women's or girls' knickers and briefs, knitted or crocheted, of wool, cotton or man-made fibres.
9.	PCS	Men's or boys' women overcoats, rain-and other coats, cloaks and capes, of wool of cotton or of man-made textile fibres. (other than parkas) (of category 15)
10.	PCS	Women's or girls' woven overcoats, raincoats and other coats, cloaks and capes; jackets and blazers of wool of cotton or of man-made textile fibres. (other than parkas) (of category 15)
11.	PCS	Men's or boys' suits and ensembles, other than knitted or crocheted, of wool, of cotton or of man-made fibres, excluding ski suits.
12.	PCS	Men's or boys' jackets and blazers, other than knitted or crocheted, of wool, of cotton or of man-made fibres.
13.	PCS	Men's or boys' singlets and other vests, underpants, briefs, nightshirts, pyjamas, bathrobes, dressing gowns and similar articles, other than knitted or crocheted. Women's or girls' singlets and other vests, slips, petticoats, briefs, panties, night-dresses, pyjamas, negliges, bathrobes, dressing gowns and similar articles, other than knitted or crocheted.
14.	PCS	Handkerchiefs other than knitted or crocheted.
15.	PCS	Parkas, anoraks, windcheaters, waister jackets and the like, other than knitted or crocheted, of wool, of cotton or of man-made fibres.
16.	PCS	Men's or boys' nightshirts, pyjamas, bathrobes, dressing gown and similar articles, knitted or crocheted. Women's or girls' nightdresses, pyjamas, negliges, bathrobes, dressing gowns and similar articles, knitted or crocheted.

17.	PCS	Women's or girls' dresses, of wool, of cotton or of man-made fibres.
18.	PCS	Women's or girls' skirts, including divided skirts.
19.	PCS	Trousers bib and brace overalls, breeches and shorts (other than swimwear) knitted or crocheted, of wool, of cotton or man-made fibres.
20.	PCS	Women's or girls' suits and ensembles other than knitted or crocheted, of wool, of cotton or man-made fibres, excluding ski suits.
21.	PCS	Brassieres, woven, knitted or crocheted.
22.	PCS	Babies' garments and clothing accessories, excluding babies' gloves, mittens and mitts of categories 6 and 36, and babies' stockings, socks and sockettes, other than knitted or crocheted of category 37.
23.	PCS	Women's or girls' slips and petticoats, knitted or crocheted.
24.	PCS	Panty-hose (tights) of synthetic fibres, measuring per single yarn less than 67, 67 decitex (6.7 tex) Women's stockings of synthetic fibres.
25.	PCS	Swimwear, of wool, of cotton or of man-made fibres.
26.	PCS	Track suits of knitted or crocheted fabric, of wool, of cotton or of man-made textile fibres.
27.	PCS	Women's or girls' knitted or crocheted suits and ensembles, of wool, of cotton or man-made fibres, excluding ski suits.
28.	PCS	Men's or boys' knitted or crocheted suits and ensembles, of wool, of cotton or of man-made fibres, excluding ski suits
29.	PCS	Men's or boy's industrial or occupational clothing, other than knitted or crocheted, women's or girls' aprons, smock-overalls and other industrial or occupational clothing, other than knitted or crocheted.
30.	PCS	Ski suits, other than knitted or crocheted.
31.	PCS	Garments, other than knitted or crocheted not specified elsewhere.
32.	PCS	Overcoats, jackets, blazers and other garments, including ski suits, knitted or crocheted, not specified elsewhere.
33.	PCS	Shawls, scarves, mufflers, mantillas, veils and the like other than knitted or crocheted, of wool of cotton or man-made fibres.
34.	PCS	Ties, bow ties and cravats, not knitted or crocheted, of wool or cotton or man-made fibres.
35.	PCS	Corsets, corset-belts suspender-belts, braces, suspenders, garters and the like and parts thereof, whether or not knitted or crocheted.
36.	PCS	Gloves, mittens and mitts, not knitted or crocheted.
37.	PCS	Stockings, socks and sockettes, not knitted or crocheted, other clothing accessories, other than for babies, other than for babies, other than knitted or crocheted.
