



## SPECIAL NOTICE TO BASMATI RICE IMPORTERS

### **Import of Basmati Rice under Pakistan-Sri Lanka Free Trade Agreement (PSFTA) for the year of 2022**

Issuance of duty-waiver recommendations by the Department of Commerce (DOC) for importation of 6,000 metric tons of basmati rice under Pakistan-Sri Lanka Free Trade Agreement (PSFTA) will commence with effect from 01<sup>st</sup> December 2022. The duty-waiver recommendations will be applicable only to **PK385 variety of Basmati rice/ Super Kernel Basmati/ Super Basmati Rice/ 1121-Kainat Rice/ D-98 Basmati Rice** varieties imported from Pakistan. In order to be eligible to apply for duty-waiver recommendations, all interested parties have to register with the DOC, located on No. 492, 2<sup>nd</sup> Floor, L.H.P. Building, R.A. De Mel Mawatha, Colombo 03.

The deadline for registrations is **18<sup>th</sup> November 2022**, while all registrations will be valid only up to **31<sup>st</sup> December 2022**. Registration hours will be **from 9.00am to 2.30pm on working days**.

#### **Documents required for New Registration**

- a) Duly completed application form - Applications can be downloaded from, [www.doc.lk](http://www.doc.lk)
- b) The original and a certified copy of the company registration\*
- c) The original and a certified copy of the TIN certificate.\*
- d) The original and a certified copy of the Form 01 or 20 (for companies)\*
- e) Names and complete contact details of company directors / proprietor
- f) Brief description of the company activities (company profile)
- g) Company bank statements for the last three consecutive months certified by the bank. If the fund balance is negative, company should provide a letter from the respective bank, confirming the availability of credit facilities for the intended importation of basmati under PSFTA
- h) Any other documents/information that would be required by the DOC
- i) Approval letter from the supervisory authority of the public organization

#### ***Additional Documents***

- j) The terms of payments (Letter of Credit, Documents against Payments, Contract) ,
- k) The exact quantity of importation
- l) The intended date completing the importation process that can be accepted to the Director General of Commerce.

*\* The original documents will be returned to the applicant after verification*

Each consignment of rice imported under this facility should accompany a quality certificate/ test report issued by the Rice Research & Development Institute, Bathalagoda and those imported basmati should comply with the minimum quality/ standards prescribed by the Bathalagoda Rice Research and Development Institute.

Clearance of each import consignment will be subject to verification of quality and health standards etc, by Sri Lanka Customs.
